APPLICATION FOR JUROR



Mattawoman Creek Art Center is seeking jurors for future art exhibitions

to be held at our spacious cathedral-ceiling gallery located in Smallwood State Park overlooking the scenic Mattawoman Creek in rural Charles County.

The following applies to most situations:

- Mattawoman Creek Art Center (MCAC) is looking for any artist with a strong background in art, either scholastically or professionally, who has experience jurying exhibitions to jury art exhibitions at MCAC.
- The juror will be required to come to MCAC on the Monday, Tuesday, or Wednesday prior to the opening of the exhibition to select from the entries the artwork to be included in the exhibition and the prize-winning entries. This jurying process usually takes about two hours.
- The juror will be required to come to MCAC on the Sunday of the reception to award the prizes and give a gallery talk about the prize-winning artwork. The juror is requested to stay to talk to individual artists about their entries or art in general. This process usually takes about two hours.
- The gallery talk by the juror may be video recorded to post on the Internet.
- The juror will be offered an honorarium, currently \$400, subject to change.

APPLICATION PROCESS:

1. Provide the following information in electronic format:
 - a. Your full name, email address, phone number, and mailing address.
 - b. Your biography and resume as they relate to art. Please include information (when, what exhibition, and where) about your experience as a juror of art exhibitions.
 - c. Your artist's statement.
 - d. Optional: 4 or 5 jpeg images representative of your artwork, if you care to share them with us.
2. The Artists Advisor Committee (AAC) will review your application and contact you with their decision. If the application is approved, your name will be placed on our list of approved jurors and remain on the list until further notice. If at some future date you wish to be removed from the list, we will honor that request.
3. As juried exhibitions occur, you may be contacted to find out if you are interested in being the juror.
4. If you are contracted to be juror for an exhibition, you will be asked to submit a recent photograph of yourself, plus any updates to your resume you wish to include, to be used for the juror's poster that will be displayed in the gallery for the duration of the exhibition. You will be included in a review of the poster prior to printing.

SUBMISSION: For your convenience, an application form is attached. You may use it or submit the required information on you own document(s). The above-listed files may be submitted electronically via email, or alternatively, be placed on a CD or thumb drive in an envelope addressed to "MCAC - Attn. AAC" and mailed to the MCAC post office box address, or hand-delivered to MCAC gallery during business hours, Friday through Sunday from 11:00 a.m. to 4:00 p.m. The preferred format for the written documents is MS Word. Adobe Acrobat (pdf) format is acceptable, but not preferred.
