

**MATTAWOMAN CREEK ART CENTER**  
**30<sup>th</sup> Annual Open All-Media Juried Exhibition**  
**Friday, April 26 – Sunday, May 26, 2024**

**ELIGIBILITY**

Open to all artists 18 years or older. All artwork entered must be original. Artwork may not exceed 6' in any dimension nor weigh more than 40 lbs., except by special permission. We cannot accept installation artwork. Artwork shown in the MCAC gallery or gift shop within the past 12 months is not eligible, nor is artwork shown in any of MCAC's previous juried exhibitions.

**AWARDS**

Awards totaling \$1,000 will be made by the juror.

**ENTRY PROCEDURE**

All entries must be **hand delivered** to Mattawoman Creek Art Center on the dates specified as Artwork Delivery dates.

*Entry into this exhibit constitutes an understanding and acceptance by the artist of the conditions set forth in this document.*

**ENTRY FEE**

The entry fee is **non-refundable**. Fee for 1 to 3 pieces of artwork:  
\$30.00 for current MCAC members.  
\$45.00 for non-members.

Cash or check preferred to card. Make checks payable to **MCAC**. **Members entering artwork are requested to sign up to docent.**

**PRESENTATION**

Artwork must be clean, professional in appearance, and suitable for community viewing. All artworks must be delivered ready for installation. The MCAC Framing Standards and Display Standards for 3-Dimensional Artwork (on the web site) apply. Artwork intended for the wall must be prepared with picture hanging wire. No saw-tooth hooks will be allowed. **Each piece must be clearly labeled with the title, medium, price, and name and phone number of the artist when delivered.** Artists may use their own labels or the labels provided by MCAC at time of entry, to be affixed to the back of each piece. *MCAC reserves the right to refuse any improperly presented artwork or artwork inappropriate for community display.*

**NOTIFICATION OF UNACCEPTED ARTWORK**

Artists will be notified by phone or email if any of their artwork is declined. No notification is made to artists if all their artwork is accepted. See Pick-up of Unaccepted Artwork for dates.

**SALES**

Two of your entries must be for sale. MCAC will retain a 25% commission on sales. IRS Form W-9 is required of anyone receiving \$600 income from MCAC in one calendar year. Artwork sold may not be removed until after the show ends.

**LIABILITY**

MCAC will not be responsible or liable for any lost or damaged artwork. Insurance on artwork is the responsibility of the artist.

Saturday, April 27 from 11:00 a.m. to 2:00 p.m.

**EXHIBITION DATES**

Friday, April 26 through Sunday, May 26, 2024.  
The gallery is open on Fridays, Saturdays, &  
Sundays from 11:00 a.m. to 4:00 p.m. and is free.  
The park gate fee is waived for MCAC visitors.

**RECEPTION and AWARDS CEREMONY**

**Sunday, May 5 from 1:00 – 4:00 p.m.**  
Awards at 2:00 p.m., followed by juror's talk.  
The reception is free and open to the public.  
**Participating artists are encouraged to attend.**

**ARTWORK RETRIEVAL**

Unsold artwork must be picked up by the artist on:  
Sunday, May 26 from 4:00 p.m. to 5:00 p.m. or  
Monday, May 27 from 11:00 a.m. to 2:00 p.m.  
Friday, May 31 from 1:00 p.m. to 3:45 p.m.  
After 30 days, artwork becomes MCAC property.
